Term	Definition
Applicants:	Those individuals included in an application. Many applications can have more than one applicant. Individuals who apply for more than one visa or permit in a given year will be counted on each application.
Financial Year:	All data, unless otherwise stated, is for the financial year (1 July – 30 June).
Nationality:	The name of the country that issued the client's passport.
Applications Decided:	Applications which were approved or declined based on policy criteria. This does not include applications which failed lodgements or INZ refused to consider.
Applications Accepted:	Applications which meet the lodgement requirements and have been accepted for consideration.
Application Category:	Refers to whether an application is a visa or a permit application. Note that after 1 November, 2010, all applications are visa applications.
Application Criteria:	Refers to the specific policy name under which an application is processed.
Applications Approved:	Applications which were approved based on policy criteria.
Applications Declined:	Applications declined: Applications declined based on conditions such as not meeting policy criteria, withdrawn due to a client request, withdrawn and replaced by a new application or withdrawn due to a subsequent application being approved. This does not include applications which failed lodgements or INZ refused to consider.
